#### **BACKGROUND ON BILLS**

• The Assault Weapons Ban of 2023 - Senate Code S. 25 / House Code H.R. 698: The AWB would make it illegal to import, sell, manufacture or transfer assault weapons and large-capacity magazines without criminalizing those already in existence. Chuck Schumer needs to call this to a vote, anyone including Virginias can ask him to call this to a vote. This was in effect from 1994-2004. While it was in effect mass shooting fatalities decreased by 70%. Since it expired, the US experiences a 183% increase in gun massacres and a 239% increase in gun fatalities.



#### **BACKGROUND ON BILLS**

- The Office of Gun Violence Prevention Act of 2023 – Senator Code 2. 951 / House of Reps Code H.R. 1699: This bill would create an office consisting of government officials and those affected by gun violence to
  - Advance policy recommendations about guns
  - Advance accurate data and research about gun violence
  - Perform state and local outreach and education
  - Coordinate across various sectors
  - Maximize and coordinate programs and services related to preventing gun violence



#### **BACKGROUND ON BILLS**

The Bipartisan Background Checks Act of 2023 – Senate Code S. 494 / House Code H.R. 715: This bill aims to close several loopholes in our current federal laws that require background checks for any firearm purchases.

Examples of loopholes include:

- No background checks at gun shows, yard sales, craigslist
- The Charleston Loophole (if a background check does not come back to a licensed seller within three days, they can still sell the gun to the buyer. Typically when there is a delay it means that there is a red flag in a background check, including with the 2015 Charleston Church Shooting, where the perpetrator would have failed the check).

According to a recent Fox News Poll, 87% of voters support universal background checks.
